Important Questions	Answers	Why This Matters:
What is the overall deductible?	For participating providers \$500 individual/ \$1,000 family and non-participating providers \$750 individual/ \$1,500 family. Doesn't apply to preventive care.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> listed in your complete terms of coverage.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and <u>before</u> you meet your <u>deductible</u> . Are there other deductibles for specific services?	No.	You don't have to meet separate <u>deductibles</u> for specific services.
What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	Medical: participating providers \$2,500 individual/ \$5,000 family; non-participating \$5,000 individual / \$10,000 family; Prescription Drug: \$4,100 individual/ \$8,200 family.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own out-of-pocket limits until the overall family <u>out-of-pocket limit</u> has been met.

What is not included in the <u>out-of-pocket limit?</u>	Medical: Coinsurance for certain services, premiums, balance-billing charges, and health care this plan doesn't cover. Prescription Drug: See Prescription Dug section for limitations, exceptions, and other important information.	Even though you pay these expenses, they don't count toward the out-of-pocket limit.
Will you pay less if you use a <u>network provider</u> ?	Yes. See <u>blueshieldca.com/oc</u> or call <b>1-888-235-1767</b> for a list of <u>network</u> <u>providers</u> .	This <u>plan</u> uses a <u>provider network</u> . You will pay less if you use a <u>provider</u> in the <u>plan's</u> network. You will pay the most if you use an <u>out-of-network provider</u> , and you might receive a bill from a <u>provider</u> for the difference between the <u>provider's</u> charge and what your <u>plan</u> pays ( <u>balance billing</u> ). Be aware, your <u>network provider</u> might use an <u>out-of-network provider</u> for some services (such as lab work). Check with your <u>provider</u> before you get services.

## Does this plan provide Minimum Essential Coverage? Yes
