Subject: AB 2843 Cost Share Waivers for SELECT services apply to CalPERS plan members, effective

January 1, 2025

The California Public Employees' Retirement System (CalPERS) announced that CalPERS members who select a 2025 CalPERS commercial HMO or PPO health benefit plan shall not be held financially responsible for cost-sharing when provided with emergency and follow-up care (medical, surgical, or behavioral health services, including substance abuse disorder) arising from an instance of rape or sexual assault, as described in California Assembly Bill 2843 (AB 2843).

The cost-sharing waiver described in AB 2843 will become mandatory for most commercial HMO and PPO benefit plans offered in California beginning July 1, 2025. Under the law, the waiver for an eligible patient will continue for nine (9) months following the initial qualifying incident. However, <u>CalPERS is including this cost-sharing waiver for applicable services and treatments to eligible CalPERS members beginning January 1, 2025 and making the waiver applicable to continuing care for the eligible member indefinitely. Time limits may be implemented later.</u>

Key information regarding encounter/claims submission for treatments

The cost-sharing waiver described above shall only apply if the eligible enrollee's treating practitioner or provider organization submits all requests for encounter and/or claim payment using the <u>accurate</u> diagnosis codes specific to rape or sexual assault.

- Under AB 2843 "Follow-up health care treatment" includes medical or surgical services for the
 diagnosis, prevention, or treatment of medical conditions arising from an instance of rape or sexual
 assault. CalPERS has added behavioral health treatment, including substance use disorder, to be
 included in the care to which the cost-share waiver is applied when it is specifically related to rape and
 sexual assault.
- "Cost-sharing" includes any copayment, coinsurance, or deductible, or any other form of cost-sharing paid by the enrollee other than their premium or premium share.
